The amount should be deposited in above mentioned account by YCTCs before the start of examination but after the closure of scheduling window for a respective examination cycle. YCTC needs to enter the examination fee details and upload the scanned copy of bank receipt on EEAS portal for subsequent exam cycles. However, for the July 2016 cycle, YCTCs need to deposit the examination fee (for actual number of exams taken) to the above account and need to share the details on email Id. sarveshg@hpe.com latest by 18th Oct 2016.

From this examination cycle, details of state's share of fees also needs to be entered in the EEAS portal and scanned copy of the bank deposit receipt needs to be uploaded therein as well. The process and account details for this will continue to prevail as per existing guidelines. All deposits and details are to be made individual YCTC-wise and clubbing of the fees amounts for more than one YCTC will not be allowed.

Issuance of Certificate will be enabled in the EEAS portal for the respective YCTCs only after details of the deposit (State Share and Examination Fee) is entered in the portal and the scanned copy of the receipt/online bank confirmation details are uploaded therein and approved by designated approvers. Process of entering details and upload of challan will be separately communicated to all the YCTC later.

The dates for the next online examination is as under:

- **Mock examination/Demo examination to be made available from 7th October, 2016 till 06th November, 2016.**
- **Scheduling of Examination for candidates to be allowed from 15th October, 2016 till 31st October, 2016 (both days inclusive)**
- **State's share of fees to be deposited on or before 05th November, 2016. Examination fee to be deposited on or before 05th November, 2016.**
- **Online Examination period: 07th November, 2016 till 22nd November, 2016.**
- **It is to also inform all the YCTC that once the scheduling window is closed, it will not be re-opened for same examination cycle again.**
